Dear Applicant:

Permission subject to the following conditions is hereby granted to construct the City of Beardstown Campground consisting of 7 new RV full hookup sites, kayak launch, pavilion, playground, restroom, shower house, and an on-site potable well to supply water. This is in accordance with the Recreational Area Code, Part 800 and the plans prepared by Benton & Associates, Inc. and received by this Department on July 21, 2021.

General Conditions

1. This authority is granted in accordance with the provisions of an Act entitled, "Campground Licensing and Recreational Area Act" and subject to the provisions thereof.

2. This authority shall not be considered in any manner affecting the title to the premises upon which the recreational area in question is located.

3. This authority does not in any way release the permittee from any liability for damages to persons or property caused by or resulting from installation, maintenance or operation of the campground, located and constructed in accordance with the plans and specifications herein referred to.

4. The Illinois Department of Public Health, in issuing this permit, has relied upon the statements and representations made by the permittee in the application here for; and in case any statement or representation in said application is found to be incorrect, this permit may be revoked without further notice and the permittee thereupon waives all rights thereunder.

PROTECTING HEALTH, IMPROVING LIVES Nationally Accredited by PHAB 5. There shall be no deviations from the plans and specifications submitted with the application for this permit unless revised plans and specifications thereof shall first have been submitted to the Illinois Department of Public Health and a supplemental written permit issued, therefore.

6. The Illinois Department of Public Health or any person duly authorized by it may at any time during the progress of the construction under authority hereof, have the right and authority to inspect such campground area during the progress thereof, and such Department or its duly authorized agent shall have the authority at any and all times after the erection or the installation of such campground to inspect the same or the operation thereof.

7. This approval takes into consideration adequacy of the various campground facilities and their conformance with the adopted sanitary requirements and not the structural stability nor durability of any units or parts of the campground project that will not affect the safety or sanitary quality.

8. The Illinois Department of Public Health and the Cass County Health Department shall be notified when the subject project is initiated, when the project is completed and prior to operation. 9. This permit is granted with the understanding that the facilities covered by this permit conform to all other State and local regulations and ordinances.

10. This project shall comply with the Illinois Plumbing License Law and Illinois Plumbing Code. All plumbing shall be installed by a current Illinois registered and licensed plumbing contractor in accordance with Illinois Plumbing License Law 225 ILCS 320/13.1. All installed plumbing shall not be enclosed, covered up or used until the system has been inspected and approved by a licensed plumbing inspector as per Illinois Plumbing Code 890.1910.

Prior to operating the campground, the owner or prospective operator of the camp must first obtain an operating license from this Department. The owner should arrange for a code compliance inspection of the facility by contacting Joe Mitchell of our Springfield Office at 217-278-9493. The findings of this inspection will determine if campground operating license will be issued for this facility.
